2. Fees apply to all participants, youth and adults, Reservation Fees and Signed paperwork MUST be received in the CATRON office within the two- week tentative period or the reservation will be removed from the calendar.
3. To reserve CATRON for day or overnight use, the CATRON registration procedures apply. Unless otherwise indicated, the Program Center will be reserved for you.
4. There is a minimum of Six (6) participants. The maximum Twenty (20).
5. Juniors must be 10 years old, currently in or have completed fourth grade to participate on the Archery Course.
6. No Come-Alongs: youth or adult may join a group on The Archery Course.
7. Time on the range can be anywhere from two (2) to four (4) Hours depending on the number of participants.

**RULES and REGULATIONS FOR USE OF CATRON and THE ARCHERY COURSE:**

1. All rules and procedures established by Girl Scouts –Homestead Council for use at Catron must be adhered to by all groups.
2. Groups will not be permitted on The Archery Course unless they are participating under the guidance of a Girl Scouts – Homestead Council trained instructor. Only equipment provided by CATRON-Camp and Retreat Center may be used on The Archery Course.
3. A minimum of 6 participants is required for an Archery opportunity. The maximum 20.
4. Youth who are currently in or have completed fourth grade or are 10 years old and above may participate on the Archery Course.
5. Youth younger than 10 years of age may not participate on The Archery Course.
6. No Come-Alongs (Youth or Adult) are allowed with the group while on The Archery Course.
7. The Archery Course will only be cancelled for the following weather: Thunder, lighting, excessive rain.
8. Participants should dress for the weather, socks and shoes. **NO SANDALS**
9. Sunscreen and insect repellent are suggested. A cap is always advisable.
10. Alcoholic beverages and controlled substances are prohibited.
11. Firearms, Fireworks and concealed handguns are prohibited on CATRON Camp and Retreat Center property.
12. Pets are prohibited.
13. Use of non-passenger or recreational vehicles, such as mopeds and all terrain vehicles, is prohibited.
14. Smoking is not permitted anywhere at CATRON.
15. **Adult in Charge must collect the following information about each participant: Names and addresses of all participants, Emergency contact names and numbers, A listing of any persons with known allergies or health conditions requiring treatment, restrictions, or other accommodations while on sit, for minors without a parent on site, Signed permission to seek emergency treatment or a signed religious wavier.**
