

# OUTSTANDING LEADER ENDORSEMENT FORM (Nomination and 2 Endorsements)

**DUE: March 1**

Be sure that all forms are complete and are typed or legibly printed using black ink. If more space is needed, you may attach one additional sheet of information. Submit the completed form to the **Service Unit Manager by March 1.**

The Service Team will make its decision based on what you write about this individual, so **assume that all they know about this individual is the information you have given them.** It is important that what you include clearly supports the stated criteria for selection!

**Description:** Recognizes Leaders, Co-Leaders, and Assistant Leaders whose work with girls is so outstanding that it merits recognition by the Service Unit.

## Nomination and Approval Procedures

Someone submits a completed **Nomination Form** and asks **two** additional individuals to complete **Endorsement Forms**. The **Service Unit Team** reviews the Nomination Packets and annually selects **one or two Leaders** and notifies the nominators of their decision. A Leader is **eligible to receive this award only once.**

## Criteria for Selection

1. Registered adult member.
2. Has completed *Fundamentals of Girl Scouting* and *Age Level Troop Leadership* classes for the age levels they lead.
3. Has demonstrated competence in all of the following areas: girl-adult partnership, communication, pluralism, program delivery, and membership development.
4. Has provided outstanding service that **significantly exceeds expectations** for the position as outlined in the position description.

## The Award



Recipients receive a pin with a leadership torch design against a yellow background. It is worn on the right side of the uniform below the nametag. It is presented at the annual Service Unit Awards Event.
