Nomination and Approval Procedures

Someone submits a completed **Nomination Form** and asks **three** additional individuals to complete **Endorsement Forms**. The Council Awards Task Group reviews the Nomination Packet and makes a recommendation to The Board of Directors.

1. Registered adult member (volunteer or staff).
2. Has provided outstanding service in a way that furthers the council's goals.
3. Their service goes above and beyond what is included in the position description for the position held.
